Concord Free Public Library Kindle Circulation Policy

The Concord Free Public Library is pleased to offer Kindle eBook readers for loan to library patrons. Library patrons who are 18 years of age and older must have a signed "Kindle Borrowing Agreement" on file assuming financial responsibility for lost or damaged equipment in order to check out a Kindle. Library patrons who are minors (under 18 years of age) must have a signed "Kindle Borrowing Agreement for Minors", signed by a parent/legal guardian, on file in order to check out a Kindle.

Loan period: 2 weeks with no option for renewal.

\$2/day late fine

Kindles are available for request by Concord residents only.

Limit: 1 Kindle per person

Use of the Kindle is restricted to the content provided. The addition or deletion of books to the Kindle is prohibited.

Please charge Kindle before returning.

Do not place Kindles in book drops (outside or inside).

Kindles must be returned to the Circulation Desks at either the Concord Free Public Library's Main Library at 129 Main Street or the Fowler Branch Library at 1322 Main Street.

Patrons are responsible for any damage, loss, or theft of the Kindle while it is checked out to them. Do not leave the Kindle unattended while it is checked out to you.

Replacement costs are as follows: Lost or damaged Kindle - \$139 Processing fee - \$10 Cover and Travel Case - \$60 Adapter - \$15.00 Total Cost= \$224
